Product description

Antigravel forms a protective layer against rust, salt sand and stones.

Properties

- When dry, provides a tough elastic film excellent resistance to gravel
- Does not contain bitumen nor asphalt
- Can be painted or sprayed.
- The dry layer is not affected by water nor solvents

Applications

- Protects the lower flanks of the car body against stones and corrosion.
- The film also largely absorbs noise and vibration
- Anti-gravel below the bumpers and side panels of cars.
- Anti-resonance product in wheel arches and undersides of cars.

Packaging

Colour: black, grey, white Packaging: 1 kg tin

Shelf life

2 years in unopened packaging in a cool and dry storage place at temperatures between +5°C and +25°C.

Substrates

Substrates: metals

Nature: rigid, clean, dry, free of dust and

grease

Surface preparation: Remove rust. Rough grinding of smooth surfaces improve the

adhesion.

We recommend a preliminary adhesion test on any substrate.

Application method

Make sure that the underside of the car is completely dry, clean and free of grease. Cover the parts that do not need a treatment. Shake the can at least for 20 seconds. Antigravel can be applied with roller or brush, but is best sprayed undiluted with an air pressure or airless gun (recommended spraying pressure: 4bar and the nozzle opening 2-4mm).

Cleaning: acetone After curing can only be removed mechanically.

Repair: With the same material.
